The applicant must attach a copy of the company's excerpt from the commercial register and/or from the professional and trade register and a copy of the articles of association as well as the forms "Applicant", "Company" and "Managing director", and confirm by his/her signature that the forms have been filled in truthfully and accurately.

If the contact stated in the "Applicant" form is not identical with the proprietor of the business, the managing director or any other person entered in the commercial register, a proxy for the contact must be enclosed with this letter.

The applicant confirms that he/she is not affiliated, as defined by § 15 of the Aktiengesetz (Stock Corporations Act), with § 36 (3) of the Gesetz gegen Wettbewerbsbeschränkungen (Act against Restraints of Competition) being applied mutatis mutandis, with more than two other members of the Cooperative with the exception of members of the Supervisory Board or the Executive Board.

The applicant commits him-/herself without restrictions and in accordance with the German Cooperatives Act and the Statutes of DENIC eG to pay the capital share of EUR 1,500 to the stated bank account of the Cooperative. The maximum number of shares that can be purchased in addition to the mandatory share is restricted to two.
