This processing of the data is based on the provisions of Article 6 paragraph 1 sentence 1 lit. f) and c) in conjunction with Article 14 paragraph 1 let e) of the General Data Protection Regulation.
- (3) Due to legal retention obligations, DENIC will store the data of the applicant until the end of the sixth full calendar year following the submission of the application.
- (4) Pursuant to Articles 15 to 18 and 20 of the General Data Protection Regulation, the applicant has the right to access, rectification, erasure, restriction of data processing and data portability to the extent defined both herein and in Articles 34 and 35 of the Federal Data Protection Act.
- (5) The applicant may lodge a claim with the Hessian Data Protection Officer regarding data protection issues.
